3. Approval of Minutes

Kelly motioned to approve the minutes and seconded by Cyndy. Minutes were approved (6-0).

4. Old Business

- a. LGW Report from Mary Anne Borge

- Emerald Ash Borer: Mary Anne noted you can treat with pesticides but not recommended and beyond that there are few management options. She recommended cutting branches back to snag height so they do not cause damage when they fall. She noted the State has a good website that can be shared with residents so they have helpful information. She also encouraged replanting when they have the ash tree removed.
- Spotted Lanternfly: Mary Anne noted the Penn State extension has very helpful information. Right now residents can find egg masses on trees and try to remove them and soak to destroy the sacks. Residents can also make tree traps that have minimal impact on other insects. Mary Anne

recommends educating residents about identifying and removing the egg masses.

- Earth Month: Lindsay noted the City is putting together a poster and website with all the information on the events that will be available.

b. Green Infrastructure Rule and Stormwater Ordinance Update

Sophie Glovier from Watershed Institute commented that they are supportive of the increased protections in the ordinance; she would encourage the City to also include redevelopment in the ordinance. Sophie noted the DEP is expected to come out with revised rules later this year around the climate change initiative, providing another opportunity to update the ordinance.

The EC noted that stormwater management is appropriate in some redevelopment projects. A motion was made by Cyndy and seconded by Doug to recommend a discussion between the planning board and council to see what is appropriate trigger for redevelopment. Motion passed (6-0).

Kate will check in with Emily Goldman on why redevelopment not included.

c. Sustainable Jersey

d. Ditching Disposables

Liz provided the following updates:

- The Library will be ordering books and City will reimburse
- Green business certification: Liz advised DEP that we will direct businesses to their statewide registry; flyer is now live on Facebook.

- The awards are in for the Sustainable Business Awards. The EC will work to organize presentation event with Mayor.

Lindsay provided the following information on the animated video: the subcommittee is working on the character and script. The EC members approved the character. Lindsay noted they hope script will be finalized for next month. EC approved the draft that Lindsay circulated earlier in the month.
