STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

Mayor Nowick called the meeting to order at 1:00 p.m. and he asked the City Clerk to read the statement of compliance with the Open Public Meetings Act into the record.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE

Mayor Nowick led the public in the Pledge of Allegiance and he asked the members of the public to continue standing for a moment of silence.

INVOCATION – REVEREND DAWN ALPAUGH

Mayor Nowick invited Reverend Alpaugh to come to the dais to give the invocation.

CERTIFICATION OF ELECTION

The City Clerk read the certification of election into the record.

Election Statement for Municipal Offices, General Election 11-08-2023

A statement of the determination of the Board of Canvassers of Hunterdon County, New Jersey, relative to an election held in the County of Hunterdon on November 2, 2022 for the election of the following mentioned offices in the City of Lambertville:

One (2) Three-year term for Council, that said Board does determine that, Karen J. Kominski and Evan Lide were duly elected to serve as Council Members of the City Council for a term expiring 12/31/2025.

OATH OF OFFICE

Karen J. Kominsky was sworn into office as City Councilwoman by Assemblyman Verrelli, with her children, Alex and Matthew DelVecchio, holding her grandmother's Bible.

Evan Lide was sworn into office as City Councilman by the City Clerk with his son, Robert, and his wife, Melissa, holding the Bible.

ELECTION OF COUNCIL PRESIDENT

Mayor Nowick asked for nomination for the position of Council President.

Councilwoman Lambert nominated Steven M. Stegman to serve as Council President. Councilwoman Kominsky seconded the nomination. An affirmative roll call vote was taken in favor of the motion by all members present. There being no other nominations for the position of Council President, Mayor Nowick congratulated Mr. Stegman.

OATH OF OFFICE – COUNCIL PRESIDENT

The City Clerk administered the Oath of Office for the position of Council President to Steven Stegman.

COMMENTARY

Mayor Nowick welcomed the public to the reorganization meeting and he recognized the following people in the audience: Mayor Janice Kovach of the Town of Clinton, David DelVecchio, former Mayor of Lambertville, and Zach Rich, Commissioner Director of the County of Hunterdon Committee and former Mayor of West Amwell Township.

Mayor Nowick stated that we are off to a great start, with a promising year with two new Council people, and he is happy to have them join us. He shared that before the meeting, he had looked back at the minutes from his first 2022 meeting and reviewed the comments made by the previous council. Council President Taylor had said that she is here because of service not because of politics, and Mayor Nowick noted that the statement struck a chord. Councilman Sanders had said that he was looking forward to working with the new mayor, and promised to "let him know when he is right and when I disagree." The Mayor said that Councilwoman Lambert spoke about civility, compromise that works, and the collaboration that comes from partnership, and shared that those ideas have guided his leadership style this year. Collaboration and compromise. Councilman Stegman had noted that "the five of us can't do it alone." Mayor Nowick continued to say that last year was about civility, kindness, compromise, gratitude, generosity and communication, and those are the things that will continue to guide us. He thanked his husband Paul who is in Cape Cod having fun, and his children Emerson, Henry and Riley. They have all been very supportive of his efforts. Coming into this role, he was nervous, but set his compass to earn people's trust, and to feel as though he can make a difference and he was hopeful that he was able to accomplish that. In 2022, he opted not to take the Mayor's stipend that was offered. This year, he plans to accept his stipend and donate the full amount to organizations in Lambertville and nonprofits. This reinforces his love and gratitude for our community.

Council President Stegman commented that he is honored to be sitting here with these 7 people who have gained the trust of the public. He noted that the public is very paramount in his mind. We can't do this alone. He looks forward to working with Councilwoman Kominsky, Councilman Lide and Councilwoman Lambert. He said we are here because we were voted by the people to do the job. He trusts people will stay involved and informed so we can continue to meet the challenges and do with it compassion.

Councilwoman Lambert commented that she is also honored, "I feel grateful every day that the people of Lambertville have entrusted me with this job." Having never served in government before, she's found that she enjoys it. She enjoyed working with the former Council and is looking forward to working with the new members. She said she has always worked to listen to the community. When there is a difference of opinion, you can find yourself in a place you may not have been if you didn't listen. She said she will always listen to the people, and even if she doesn't agree with them, she will stop and think it through. She thanked the residents of the City of Lambertville for allowing her to do this job.

Councilwoman Kominsky thanked everyone for coming. She thanked Alex and Matt for being the most awesome sons and for getting up before noon. She thanked Assemblyman Verrelli, Donna and Melissa for coming to the swearing in. She said Anthony represents us, and to Assemblyman Verrelli, helping people is just second nature. She thanked everyone in Lambertville for putting their confidence in her. She said she has been a resident of Lambertville for quite some time. She has learned a lot, like how to make the best meatballs ever from Aliceann and Aunt Helen. That you don't have to worry on a Ramblers day, because there are five other mothers with eyes on your child. That when you call EMS, people come with compassion. When there is a flood, everyone comes to help. When someone is sick and in trouble, you have friends come. Just a few examples of Lambertville life and the spirit of my second home town. In memory of all those who passed, we all owe it to cherish all of the things that make things special together as one Lambertville. When it comes to being on the Governing Body, she reiterates her commitment to environmental protection - "We have to set our own high standards - we can't leave it up to those who come to build here." She is committed to openness and transparency; she believes in public discussion and collaboration; and long discussion at public participation. She will work to hold the line on taxes and noted that being a careful steward of taxpayer dollars is important to her.

Councilman Lide said he echoed everything Councilwoman Kominsky said. He thanked the public for placing their trust in him. There are difficult decisions to make and work to do. He thanked his wife Melissa, who was not thrilled with his decision to run for council, and his parents. We have a lot of hard work ahead of us. There are issues with affordable housing, and we need to build consensus to handle that. Affordability is a big reason we decided to run. He thanked the Mayor for getting us ready and commented that he knows the Mayor is working hard. He is looking forward to working with Council President Stegman and Councilwoman Lambert.

Mayor Nowick asked for a motion to adopt the following proclamation honoring David M. DelVecchio for his years of service.

Honoring David M. DelVecchio

Read into the record by Mayor Nowick

WHEREAS, David M. DelVecchio was first elected to serve as Mayor of the City of Lambertville on November 5, 1991; and he was sworn into office on January 1, 1992 by the Honorable Ronald Bookbinder, Judge of the Superior Court for Burlington County; and

WHEREAS, Mayor DelVecchio served a total of nine terms, served on various boards and as the President of the New Jersey League of Municipalities, and his bi-partisan efforts led to many forged relationships and opportunities for the City of Lambertville; and

WHEREAS, his efforts were many and are all preserved in the 27 years of minutes held in trust at City Hall; and

WHEREAS, there were several historical events throughout his tenure and they include: obtained funding to flood proof the Lambertville Public School; the purchase of the Lilly Mansion at 6 Lilly Street as the new home for the Lambertville Free Public Library; revived Connaught Hill; completed various road and drainage projects; made renovations to City Hall that increased accessibility with the addition of an elevator; provided generators for City Hall, the Lambertville Free Public Library and the Phillip L. Pittore Justice Center; upgrades to Parks including Ely Field, Cavallo Park and Arnett Park; and during his term added 19.426 acres to our open space inventory bringing the total of preserved acres to 30.08.

WHEREAS, his flood mitigation efforts led to the installation of the Ely Creek Flood Gates and implemented programs to lower the cost of flood insurance in the southern part of the City.

WHEREAS, David's efforts in Historic Preservation led to the creation of the Lambertville Historic Commission, the adaptive reuse of the former Old Trenton Cracker site at the end of Lambert Lane, The Historic Lambertville House, the Historic Lambertville Jail, and the Phillip L. Pittore Justice Center where the old ACME signs still flank the interior of the building and on the tower and

WHEREAS, his legacy will continue in perpetuity in our beautiful City with what Mayor Dave called "the saddest day of the year", when the parking meters were bagged for the December Holidays

NOW THEREFORE BE IT RESOLVED by the Governing Body of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that David M. DelVecchio is hereby recognized for his many contributions to the City of Lambertville.

Mayor-emeritus DelVecchio commented that during his term he also performed the first Civil Union Ceremony, and the first same sex marriage in the State of New Jersey.

WHEREAS, Wardell Sanders is married to Erika Rubine and they raised two children, Lily and Ian who are graduates of the South Hunterdon Regional School District; and WHEREAS, Mr. Sanders was elected 5 times to serve on the Governing Body of the City of Lambertville; and for a spell, he served as Council President; and WHEREAS, throughout his term of 15 years Councilman Sanders has: been very supportive of preserving the City's Library; led a committee to create a shared services agreement with the Township of West Amwell for the Police Department: served on a committee to regionalize the South Hunterdon Regional School District; served on the PennEast Pipeline Committee where he worked with residents of Lambertville to testify at FERC and file documentation in opposition of the pipeline that led to the failure of PennEast to obtain the approvals required; and worked diligently with the public to research, discuss, and create the Ordinance allowing for Cannabis retail in Lambertville; and WHEREAS, Ward wrote the City's Pay-to-Play Ordinance in 2019, wrote the Ordinance for Film Regulations in 2022, and led the City in the 2020 Census to educate our families on the importance of being counted. WHEREAS, Section 40A:4-19 of the Revised Statutes of the Local Budget Law provides that, where any contracts, commitments or payments are to be made prior to the adoption the 2023 Budget, temporary appropriations be made for the purposes and amounts required in the manner and time therein provided; and

WHEREAS, Temporary Appropriations shall be adopted within the first 30 days of the Municipality's fiscal year, and shall not exceed 26.25% of the prior's year's adopted Budget, exclusive of appropriations made for Debt Service, Capital Improvements and Public Assistance; and

WHEREAS, the total amount appropriated in the 2022 Municipal Budget, as detailed above, was \$4,761,447.77 and

WHEREAS, 26.25% of the above amount is \$1,249,880.04

NOW, THEREFORE, BE IT RESOLVED, that an additional sum of \$1,600,328.29 be appropriated for Debt Service, Capital Improvements and Public Assistance, for a total Temporary Budget of \$2,850,208.33.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Lambertville, County of Hunterdon, that the below schedule of Temporary Budget Appropriations for 2023 is hereby adopted as the Temporary Current Budget of the City of Lambertville for 2023 and that a certified copy of this Resolution be transmitted to the Finance Office for their records.

"A Resolution to Adopt a Cash Management Plan for the City of Lambertville"

WHEREAS, N.J.S.A. 40A: 5-14 requires every municipality to adopt a Cash Management Plan on an annual basis; **NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the City of Lambertville, County of Hunterdon, State of New Jersey, that the following requirements be a part of the **2023 Cash Management Plan**, and be adhered to:

I. Cash Management and Investment Objectives

Preservation of capital; adequate safekeeping of assets; maintenance of liquidity to meet operating needs; diversification of the City's portfolio to minimize risks associated with individual investments.

II. Designation of Official Depositories

The following banks are hereby designated as legal depositories for all municipal funds:Bank of PrincetonBank of AmericaNorthfield BankPNCWells Fargo BankPNC

Prior to opening an account, each depository must submit to the Chief Financial Officer / Treasurer a copy of the Governmental Unit Deposit Protection Act (GUDPA) notification of eligibility, which is filed semi-annually with the Department of Banking each June 30th and December 31st; This list may be amended or supplemented from time to time as Mayor and Council doesn pacessary.

This list may be amended or supplemented from time to time as Mayor and Council deems necessary.

III. Cash Management

All municipal funds received by any official or employee shall be either deposited within 48 hours to an account in the name of the City of Lambertville, or shall be turned over to the Deputy Treasurer within 48 hours of receipt, in accordance with N.J.S.A. 40A: 5-15;

The Chief Financial Officer / Treasurer shall minimize any accumulated idle cash in checking accounts, by assuring that excess balances are promptly swept into the investment portfolio; Investment decisions shall be guided by the cash flow projections prepared by the Chief Financial Officer or the Treasurer; Change Funds and Petty Cash Funds are not required to be maintained in interest-bearing accounts.

IV. Permissible Investments

Bonds or other obligations of the United States of America, or obligations guaranteed by the United States of America; government money market mutual funds; any federal agency or instrumentality obligation authorized by Congress that matures within 397 days from the date of purchase, and has a fixed rate of interest not dependent on any index or external factors; bonds or other obligations of the local unit, or school districts of which the local unit is a part; any other obligations with maturities not exceeding 397 days, as permitted by the Division of Investments; Local Government investment pools; New Jersey State Cash Management Fund; Repurchase agreements of fully collateralized securities.

V. Authority for Investment Management

The Chief Financial Officer / Treasurer, and/or Deputy Treasurer is authorized and directed to make investments on behalf of the City of Lambertville with the consent of the Mayor. All investment decisions shall be consistent with this plan, and all appropriate regulatory constraints.

VI. Safekeeping

Securities purchased on behalf of the City of Lambertville shall be delivered electronically or physically to the City's custodial bank, which shall maintain custodial and/or safekeeping accounts for such securities on behalf of the City.

VII. Procedures for Disbursement of Funds

Payments shall be prepared by the Deputy Treasurer as authorized by the Chief Financial Officer/ Treasurer and submitted to Mayor and Council for their approval;

No municipal funds shall be disbursed by the Chief Financial Officer / Treasurer or Deputy Treasurer prior to approval of the Governing Body, except for: Debt Service payments; Investments;

Payroll turnovers to agency accounts; Tax payments to Hunterdon County, the South Hunterdon Regional School District, Board of Fire Commission, District 1 and the Lambertville Free Public Library shall be made in accordance with schedules provided by each taxing district; the annual disbursement of the Petty Cash Check to the City Clerk and Police Department and permit fees for special projects;

Checks approved for payment shall be signed by any of the following; 1) Mayor, 2) City Clerk, 3) Police Directorand 4) Council President and must contain three signatures:Escrow Accounts for ZBOA, PB and DevelopersChief Financial Officer's Current FundEscrow Accounts for ZBOA, PB and DevelopersTrust Other FundSUI Reserve FundGeneral Capital FundDevelopers Escrow AccountAnimal Control FundCOAH TrustLilly Mansion AccountCOAH TrustBrewery Loan Repayment AccountMunicipal Open SpaceCommunity Development Block GrantTax Title Lien Account

This Cash Management Plan shall be subject to the annual audit conducted pursuant to N.J.S.A. 40A: 5-14.

WHEREAS, the City of Lambertville is actively seeking a Judgment of Repose from the Mt. Laurel trial judge, the court-equivalent of COAH's substantive certification, for the Third Round; and

WHEREAS, Lambertville amended its ordinances to provide for the appointment of a Municipal Housing Liaison to administer Lambertville's affordable housing program on May 7, 2003; and

NON FAIR AND OPEN/FAIR AND OPEN PROCESS

Mayor Nowick commented that members of the Governing Body expressed concern for not using the Fair and Open process for the 2023 professional appointments. He asked for comments from the members of the Governing Body.

Councilman Lide commented that he had concerns about the Nonfair and Open Process and would prefer moving forward that the City use the Fair and Open Process.

Councilwoman Kominsky concurred. She commented that the Fair and Open process is meant to serve the public, offering transparency through the appointment process.

Councilwoman Lambert and Council President Stegman both agreed with the comments made by the other Council members.

Mayor Nowick commented that in October, in an effort to be organized and timely, he had discussions with staff and the City Attorney. He asked about the Non Fair and Open Process. At the time, he decided to move forward with a number of appointments via the Non Fair and Open Process. He sent the list to the members of the Governing Body for review. For him, using that process was only meant to streamline things with people that we already felt confident about. It didn't seem prudent to put out an RFP when there likely wasn't going to be a change to our current appointments. That said, the Mayor stated that he is happy to use the Fair and Open process moving forward. Mayor Nowick did note that using the Non Fair and Open process requires the firm appointed to provide the political contributions made in previous years and the contract prohibits them from making contributions in the next year.

<u>RESOLUTION 18-2023</u>: A Resolution Authorizing the Award of a Non-Fair and Open Contract for the City Attorney and Redevelopment Attorney

Mayor Nowick read the resolution into the record by title and he nominated William Opel of McManimon Scotland and Baumann, LLC to serve as the City Attorney and Redevelopment Attorney for a one-year term at a rate not to exceed \$\$60,000.00 for the City Attorney, and \$1,000.00 for Redevelopment Projects, with an hourly rate of \$185.00 for both positions.

WHEREAS, the Certified Municipal Finance Officer has certified that funds are available in the 2023 Budget – N.J.A.C. 5:30-5.4.

NOW THEREFORE, BE IT RESOLVED that the Governing Body of the City of Lambertville authorizes the Mayor and City Clerk to enter into a contract with McManimon Scotland Baumann, LLC as follows:

<u>RESOLUTION NUMBER 22-2023</u>: A Resolution to Appoint a Company to Provide Animal Control for the City of Lambertville for the 2023 Calendar Year

Mayor Nowick read the resolution into the record. He further commented that in the last few days, he received 6 letters in opposition of this appointment. The City recognizes both its statutory and legal obligation. The letters were all received in the past couple of days. Mayor Nowick commented that there is a memorandum available that detailed the interview process. He worked with the City Clerk and the Officer-in-Charge of the Police Department on this appointment and they were present during interviews. At the end of the day, he said he is confident moving forward with this appointment. He recognized that not all appointments or decisions are easy, but we do the best we can and act in good faith.

Councilwoman Lambert commented that she too received emails and telephone calls. She had a few conversations with members of the public and appreciates everyone who reached out to share their thoughts. She asked if the appointment would be for the year or if we could make an interim appointment.

Mayor Nowick responded that it is customary to appoint for a year, and then conduct a 6 month formal review to give feedback. In this case the City is prepared to offer a six month contract.

Councilwoman Lambert agreed that a mid-year review would be helpful. We have received different comments but all of this info bubbled up at the last minute. The City is in a bind, we are

required to appoint someone and we've gone through the interview process, and changing the direction at this point will put us out of compliance. Moving forward and doing an assessment mid-year seems prudent. She also suggested that next time we do a request for proposals that we clearly specify how we want this service to operate within our community and what we require. We need to outline whether it will be solely by request or they would be working in the community at will. Those types of things bubbled up and we should take a closer look to specify our requirements and make sure bidders have the opportunity to articulate how they will meet those requirements.

Councilwoman Kominsky commented that since we have a lot of input and concern, maybe we could put together an ad-hoc group to review the work as time goes along, as well as researching the information, the standards and the experiences with different companies so we can make a harmonious decision. She also commented that it would be helpful to hear the public comment prior to making a decision about the resolution.

Discussion ensued and after some discussion, the members of the Governing Body agreed to take public comment before ruling on the resolution.

PUBLIC COMMENT:

Mayor Nowick read the rules of engagement into the record.

Zanya Gissler of Kingwood Township, NJ, a business owner in Lambertville for over 20 years. She thanked Councilwoman Kominsky for allowing the public comment period. She said she cares deeply about this community, and that she is very active in the dog world. She is a dog trainer, she travels around the country. Unfortunately, she took her eye off one of her dogs for one minute and it bit a child. This has been traumatic. St. Hubert's interviewed her at length and realized that this was a one-time incident. Two months after the event, she received notices at her house to call Animal Control Solutions. She stated that they showed up at my house with a State Trooper with a piece of paper requiring that she surrender her dogs. She had to hire an attorney and fight to prove the dogs were not dangerous dogs. She spent \$5,000 to prove her dogs were not dangerous. The dogs were taken to an impound, and she was not allowed to see them. When she called and expressed concern to Animal Control Solutions the representative laughed at her.

Judy Gleason of Lambertville commented that she wanted to identify a couple of things. If you change the one year contract to 6 months or less, it has to be changed in the resolution. I would recommend 60 days as the trial. Secondly, there are many issues around this particular service, and one issue is with enforcement. We have a money thing beneficial to the town – if there is enforcement carried out by the entity, there is a monetary benefit to the City, and that is a valid thing to consider. She thanked Councilwoman Kominsky for the suggestion of a committee. Perhaps people from the City could volunteer to be involved. She thanked the Council for the opportunity to comment before the vote.

Lori Stagnitto of New Hope, PA, moved to Lambertville 29 years ago. Formed Lambertville Animal Welfare 15 years ago. Ms. Stagnitto gave an overview of the nonprofit she organized and the services they provide the community. She started the Trap Neuter and Release program in the City because of the 100 free roaming cats in Lambertville. Carolyn Murphy rounded up 30 of

them and they were spayed. We are down to two left in the City of Lambertville. Hunterdon County does not have a municipal shelter. She has formed collaboration throughout Mercer County, Hunterdon County and Somerset County so that we all take the animals and they are not killed. Carolyn and I collaborate closely with Tabby's Place, dead or alive. Carolyn has a contract in Hopewell for deceased dogs in their freezer. No dogs are killed. Other animal control services don't have these types of places. So much more I could say. I know a lot of this is politics from when Carolyn left. It was because she did not have what she needed from the City of Lambertville to legally do her job.

Lauren McWater of York St. thanked the members of the Governing Body for reconsidering the year contract. It is a wise thing. She knows Zanya as a passionate, educated dog owner. She has a personal experience with Carolyn Murphy, she has taken care of my animals. I would like to say that Carolyn is very passionate and bends over backwards for the animals. I urge you to consider 60 days instead of six months, and to explore all of the options.

Eve Rangle of Delaware Township. She was involved in a rescue with Animal Control Solutions where dogs that were seized. 2 cats were left behind and she took care of them. The animals were not treated properly when they were seized. The neighbor was so upset they called the prosecutor's office. I've heard concerns from other people about the conditions of seized animals.

There being no more in-person comments, Mayor Nowick asked if there were any hands raised on Zoom. No hands were raised. We had 11 people participating on Zoom.

Mayor Nowick asked for a motion to close the public comment period for Animal Control Officer. Councilwoman Kominsky made the motion and Councilman Lide seconded the motion. An affirmative voice vote was taken in favor of the motion to close the comment period for the resolution to award a contract to Animal Control Solutions to serve as the City's Animal Control Officer.

Discussion ensued. Mayor Nowick commented that he believes a 6 month contract is appropriate and would allow us to make a realistic assessment. We have a number of references for this group including Raritan Township, Readington Township, Lebanon and Franklin who are all happy with their services.

RESOLUTION NUMBER 22-2023

WHEREAS, the City Attorney has reviewed the quotes and has determined that they are responsive and responsible; and

Jeff Tittle welcomed the new Council members. He complimented Councilman Lide's great legal background and Councilwoman Kominisky's background in the state government. He suggested that the City speak with East Amwell Township about animal control. He commented about the topic of public comment and suggested that the City consider putting it at the beginning for agenda items only, and expressed his interest in increasing the time limit.

Mayor Nowick commented that he is willing to have a conversation about this.

Councilman Lide commented that people should not have to wait until 9:30 to speak about something. People have busy schedules. I hope we can do that in the future.

Tom Servick thanked Mayor Nowick, Councilwoman Lambert, and Council President Stegman for a fine year. The town moved in a much better direction. He said he appreciates the Lambertville Matters, and he said think it's very advantageous to the public to make comments before they are voted on.

Lori Stagnitto, of New Hope said she is devastated. She has worked in our community for three decades. She spoke about an incident with a resident and a lost cat and said Animal Control

Solutions isn't going to go out of their way to find an animal. She felt she was disrespected. She is an Animal Control Officer; she has worked with other Animal Control Officers and she knows the dirty and the ugly behind them. The last time she was in front of Council was when the Animal Control position was on the agenda and the Governing Body switched to St. Hubert's. After that, she received a threatening letter from the attorney of Animal Control Solutions. I have had two threatening letters and I am not allowed to say anything about them. Hillsborough is going to court. You will not get a six month review because no one will use them - no one will be calling animal control.

Zanya Gissler of Kingwood Township said she wanted to make something very clear, they came to my home illegally. It was not their jurisdiction. They took my dog illegally. The dogs were impounded. If it wasn't for Annie Trinkle they would have been there until my court case. They lied. Waved a piece of paper that was not a court order. \$75 per dog per day. 75 x 3 per day. Kingwood Township came to my rescue. These are the type of people you are dealing with.

There being no further public comment, Mayor Nowick asked for a motion to close the public comment period. Councilwoman Lambert made the motion and Council President Stegman seconded the motion. An affirmative voice vote was taken in favor of the motion by all members present. MOTION CARRIED.
