Please be advised that you are required to submit certifications that the property taxes are up to date. Please contact the Clerk's Office to obtain this certification. They can be reached at (609) 397-0110 ext 12 or via email at <u>deputyclerk@lambertvillenj.org</u>.

A Zoning Permit is different from the Zoning Board of Adjustment application. Zoning permit approval is required for all exterior projects that include the changing of the footprint of the property, such as; additions, new buildings, sheds, decks, patios, pavers, signs, mechanical equipment, etc.

Any change in occupancy for a commercial space, even if the use is permitted in the zone, requires the submission of & approval of the Zoning Permit, prior to any new tenant occupancy. It is also recommended that you submit a floor plan with your application.

In addition to new commercial occupancy, any new proposed signs, or changes to existing signs, also need to be included on the application. Please provide full dimensions of the sign, proposed location of the sign and a photocopy of the proposed sign. In most cases, depending on the zone, you may also be required to obtain additional outside agency approval - Construction Permit, Historical Preservation Commission and/or D&R Canal Commission approval.

When making changes to the exterior of the property, a site plan or survey will be required, with all proposed information indicated on the plan.
