## NOTICE TO BIDDERS

NOTICE IS HEREBY GIVEN that sealed bids will be received by the City Clerk for the City of Lambertville, County of Hunterdon, State of New Jersey (the “City”) on **Thursday, May 9, 2024, at 11:00 a.m.** (the “**Submission Date**”) prevailing time at City Hall, located 18 York Street, Lambertville, New Jersey, 08530 at which time and place bids will be opened and read in public for:

### **2024 Storm Sewer Maintenance Project**

The intent of this Request for Bids (“**RFB**”) is to select a qualified individual or firm to provide the abovementioned services. Specifications and other bid information may be obtained in the Clerk’s Office at City Hall, located at 18 York Street, Lambertville, New Jersey, on Mondays, Wednesdays and Thursdays from 9 am to 4 pm, and on Tuesdays from 9 am to 7 pm.

Bids must be received by the City, addressed to the City Clerk, Cynthia L. Ege, CMR, RMC, 18 York Street, Lambertville, New Jersey 08530 by no later than Thursday, May 9, 2024, at 11:00 a.m., at which time they will be publicly opened and read aloud. Bids will be received by hand delivery, mail, or delivery service in accordance with the instructions provided herein up until the date and time indicated above. The City will not be responsible for packages not arriving at the time and place designated, irrespective of the date and time the package was mailed, posted, or left with a delivery service. Bidder assumes any and all risk of late delivery of its bid. Bids not received on time will be returned to Bidder unopened.

Bid Packets must be accompanied by a Statement of Consent of Surety from a surety company holding a Certificate of Authorization to do business in the State of New Jersey and either a Bid Bond or a Certified Check drawn to the order of “City of Lambertville” for not less than ten percent (10%) of the total bid price amount, except that the check shall not exceed \$20,000.00. The successful Bidder is hereby notified that Performance and Payment Bonds for the full amount of this Project is required.

A pre-bid conference will be held on **Friday, April 26, 2024 beginning at 10:00 a.m. at 18 York Street.**

The City will award a contract or reject all bids within sixty (60) days after receipt of the bids unless otherwise agreed by the parties. The City reserves the right to reject any or all bids or to waive any informalities in any bid received and to accept the bid which in its judgment will best serve the interest of the City.

Bidders are required to comply with the requirements of (i) *N.J.A.C. 17:27*; (ii) *N.J.S.A. 10:5-31 et seq.*; (iii) *Business Registrations* (N.J.S.A. 52:32-44); (iv) *Prevailing Wage Act* (N.J.S.A. 34:11-56.25, et seq.); (v) *Public Work Contractor Registration* (N.J.S.A. 34:11-56.48); and (vi) *Affirmative Action Requirements* (N.J.S.A. 10:5-1, et seq.); and any other legal requirements applicable to this Project.
