Nominations from the Floor: Mayor Nowick asked for nominations for the position of Council President. Councilman Sanders nominated Julia Taylor to serve as Council President for the 2022 calendar year.

Mayor Nowick asked for any further nominations. There being no further nominations from the floor, Mayor Nowick asked for a motion to confirm the nomination of Julia Taylor to serve as Council President for the 2022 Calendar Year. Councilman Stegman made the motion and Councilwoman Lambert seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

OATH OF OFFICE - COUNCIL PRESIDENT.

Cynthia Ege, the City Clerk administered the Oath of Office to Julia Taylor to serve as Council President for the 2022 calendar year.

COMMENTARY

Mayor Nowick welcomed the members of the public to the swearing in and he thanked Rabbi Diana, Reverend Dawn, Mayors Fahl, DelVecchio and Kelly for attending today's event. He acknowledged and welcomed Mr. Gibbons of Assemblywoman Jackson's office. Mayor Nowick said hello to all of his family in New England and Massachusetts, and Aunt Peggy and Aunt Jeanette who is turning 101 and participating via Zoom. He expressed his appreciation to the members of the public and staff who were present and said he was glad to be working with everyone. Mayor Nowick commented that he is looking forward to getting to a place where we can have good conversation, and always be able to listen and not attack. He spoke of Margaret Mead; an American cultural anthropologist and he retold the story of when she was asked by a student what she considered to be the first sign of civilization in a culture. The student expected Mead to talk about clay pots or grinding stones. But instead Mead said that the first sign of civilization in an ancient culture was a femur that had been broken and then healed. In the animal kingdom, if you break your leg, you die. You cannot run from danger and no animal survives a broken leg long enough for the bone to heal. A broken femur that has healed is evidence that someone has taken time to stay with the one who fell, has bound up the wound, has carried the person to safety and has tended the person through recovery. Helping someone else through difficulty is where civilization starts and we are at our best when we serve others. He spoke about our history, Mayor Lilly, and the time he has spent at the Closson Farm. He said when he stands in the front room of the Holcombe House he is enveloped in the goodness of Lambertville. He said he loves Lambertville in the same way he loves the Holcombe House; he is a fan of the architecture of the river, the Eagles, and it will help to guide his days serving as the Mayor of Lambertville, Lambertville has a lot of broken bones, with the damage from Hurricane IDA, the political division, we really need to do our best to listen, to heal and to guide and be there for people.

Council President Taylor thanked the members of the governing body for their vote. She reaffirmed her commitment for service. She said she is here because of service not because of politics. Council President Taylor commented that there are a lot of spreadsheets and task mastering needed to get the work done to solve those broken femurs. She plans to take advantage of the kind thoughts and offers to help from the members of the public. We have big challenges ahead and I know we can do it and do it well.

Councilman Sanders addressed the members of the public present and he said this year I will be serving in my 15th consecutive year as a councilperson. I am honored to have been elected 5 times. I appreciate the opportunity to serve the citizens of the City of Lambertville. I want to point to three significant achievements over the past year of which I'm particularly proud. **First**, the City and its residents were part of a movement to oppose the PennEast Pipeline. We were one of the first cities to pass a resolution opposing the pipeline back in 2014; we formed a committee to focus and coordinate efforts of the city and its residents to oppose the pipeline; we met with our local water company, the DEP, other stakeholders; we marched in Trenton, Lambertville and elsewhere; we held community meetings in this building; we intervened in the FERC docket and submitted testimony; we even had a podcast with Sue Begent, one of our members, acting as MC and interviewing prominent voices speaking about the dangers and threats of the pipeline to our community. Our voices, and a chorus of voices up and down the proposed path, ultimately succeeded as the owners of the proposed pipeline gave up their efforts. It was a reminder that working together, as a community, we can help shape our future. **Second**, we passed a resolution banning pay-to-play as a way to ensure greater confidence in the City's decision-making. The ordinance prohibits the awarding of public contracts to certain contributors. **Third**, this year we passed a resolution to allow retail cannabis businesses in town. We organized a process to receive input from the community, many of whom had significant expertise. We allowed for written input, we held educational forums, both in person and virtually, and solicited input. The end result was that we were in the minority of communities that acted swiftly to open up our community to cannabis businesses. It's too early to claim success with our outcome, but the process was a success. We stand ready to consider applicants with a web page with a picture showing we are open for business. Included in our new ordnance is a fee associated with the sales of cannabis, that could be a key to alleviating some of our financial challenges.

Success is easier when the path is clear for a community. But we will not always have that luxury as we did with these three issues. The COVID pandemic, tropical storm IDA, and the cadence of our debt obligations will translate into three very difficult budget cycles for this City. We need to realize that there will be difficult decisions. Consensus will be more difficult, but we need to drive toward that with an open process that listens

to our community members, while recognizing that we are not likely going to please everyone with every decision.

Lastly, I think we need to recognize that members of our community are hurting. Many lost homes or had them largely destroyed. COVID has devastated families. We need to keep those less well off in our minds as we search for ways to provide assistance and comfort.

I look forward to working with our new Mayor, and promise to give him by best counsel. I'll let him know when I think he's right, and I'll let him know when I disagree.

Again, thank you to the community for your support, your engagement, and your voluntarism.

Councilwoman Lambert welcomed Mayor Nowick to the council, if for no other reason than she is no longer the Council rookie! She said she feels so privileged to serve Lambertville, and it is an honor to be sitting here, helping to craft decisions in the best interest of our community. She said she couldn't ask for a better group. She has worked with three out of the four, we have had several conversations, she has no doubt this will be a productive, and well-functioning council. She informed Mayor Nowick that he has her commitment. She said she may not always agree with you but we will do it with civility. The compromise that works as a result is often better and that is at the heart of our government, that form of collaboration, you feel so much more partnered with the people you are serving with. She congratulated Mayor Nowick and Council President Taylor on their election.

Councilman Stegman congratulated Council President Taylor and he said he is glad you are committed to step forward and steer this ship. To Councilman Sanders and Councilwoman Lambert, he said it's always a pleasure to work with both of you. He welcomed Mayor Nowick, said he was thinking about the commitment of many, and said the five of us can't do it alone and I am so glad you called out the volunteers. It's one thing to see their names and another to acknowledge all of their hard work. He said he came to council when he was fifty, I don't feel different about this city than I did then. It's very welcoming to hear from people with different ideas. You grow your bandwidth about how you feel based on the residents of the city. He said he looks forward to working with you and thank you for the great calls we had so far and let's get the work done.

V. Authority for Investment Management

The Chief Financial Officer / Treasurer, and/or Deputy Treasurer is authorized and directed to make investments on behalf of the City of Lambertville with the consent of the Mayor. All investment decisions shall be consistent with this plan, and all appropriate regulatory constraints.

VI. Safekeeping

Securities purchased on behalf of the City of Lambertville shall be delivered electronically or physically to the City's custodial bank, which shall maintain custodial and/or safekeeping accounts for such securities on behalf of the City.

VII. Procedures for Disbursement of Funds
