GOAL of RETREAT: Create a Legislative and Executive Agenda for the remainder of 2021.

Definitions:

Legislative: Projects that require Council leadership as well as public working sessions and hearings.

Executive: Initiatives that relate to City management and/or contracting; spearheaded by the Mayor's office.

Organizing: Work that does not require Legislative approval but will require Council Leadership.

Council President Taylor commented that there are significant projects, and she looks forward to working with the Mayor and Governing Body on them. She asked if there was a way to be kept apprised of Planning and Zoning Board applications so that when they are approached from members of the public about a project, they have the information required to respond. Councilman Stegman asked for the monthly reports from the department heads. The Governing Body asked for increased communications.
