BOB LONSDALE: 13 N. Union St., Unit A, Block 1035, Lot 10. Application is for sign approval.

Bob Lonsdale of Wilson Street was present to discuss the application made for 13 N. Union St. Discussion ensued.

MOTION

Vice Chair Amon made a motion to approve the application as submitted. Commissioner Closson seconded the motion. An affirmative roll call vote was taken in favor of the motion by all full members present. MOTION CARRIED.

CORRESPONDENCE

PUBLIC PARTICIPATION/ANNOUNCEMENTS.

Commissioners Easton and Glassburg recommended that the Commission take a proactive roll in the protection of local historic sites. Their recommendation included pursuing the establishment of a local landmark ordinance to designate properties historic in Lambertville. Owners would thus be able to apply for designation of their properties, further protecting the historic nature of our community. Of particular concern, and of potential application of the ordinance, is the City's possible acquisition of the Closson property and its future preservation. The Commission unanimously affirmed this effort. Commissioner Easton agreed to Chair the subcommittee to pursue such recommendations to the City.

Commissioner Toboz thanked the many new business applicants for their enthusiasm and contribution to Lambertville. He further raised that a jewelry store is anticipated to enter into the bank property at the corner of Bridge and Union. He noted that the window bars have not been replaced as were condition of site approval. The Commission will take appropriate steps to protect the historic nature of these bank window bars and will follow up with the City.

Commissioner Toboz, who is also the City Historian, also shared that the Lambertville Historical Society took an active roll in support of the City's efforts to purchase the Closson property during a recent City meeting. The Society seeks to preserve historical sites within the Lambertville area and recognizes the significance of the Closson property's history and contribution.
